# THE OPPORTUNITY

The World Childhood Foundation (Childhood) was founded in 1999 by Her Majesty Queen Silvia of Sweden, who felt a compelling need to address the social and emotional poverty of children around the world. The Foundation's focus is on protecting children from sexual abuse and supporting those who have been subject to child sexual abuse and exploitation. Childhood has invested in over 1,500 projects worldwide, impacting the lives of millions of children. From grassroots efforts to the United Nations, they act where it makes the biggest difference. In doing so, have helped to put child sexual abuse and exploitation on the global agenda.

Childhood hosts four operating offices in Sweden, Germany, Brazil, and the United States. The Sweden office oversees the international program. World Childhood Foundation USA (Childhood USA) aims to inspire, promote, and develop solutions to end sexual abuse, exploitation, and violence against children in the United States.

Childhood USA seeks a passionate and self-starting Director of Philanthropy (Director) to conceptualize and create a comprehensive fundraising program. The successful candidate will partner with Childhood USA's Executive Director, Board of Directors, and consultants to design a robust fundraising strategy, focused on the diversification and growth of philanthropic income sources. The Director will lead identification, cultivation, solicitation, and stewardship of individuals, corporations, and foundations in an environment where the prospective donor constituency is not immediately obvious. The candidate will carry a portfolio of prospects while building a robust corporate partnerships and sponsorships program.

The successful Director will ensure Childhood USA's philanthropic growth by implementing best practices in development, including a moves management system, cultivation and stewardship strategies, and calendars and systems to track philanthropic activities and events. The ideal candidate will be passionate about Childhood USA's mission and comfortable discussing and tackling difficult topics in child sexual abuse and exploitation. The Director will serve as an active and visible leader of Childhood USA's passionate charge to protect children with the poise to actively engage, inspire, and support the Board of Directors and volunteers.

The Director will report to the Executive Director. S/he will work closely and collaboratively with the Board of Directors, staff, volunteer committees, and consultants to lead Childhood USA's fundraising efforts. The candidate will partner with Childhood USA's Director of Programs to understand and create persuasive cases for support for Childhood USA's programs and funding priorities.

# ABOUT CHILDHOOD USA

In collaboration with Childhood, which guides the global vision and strategy, Childhood USA works in three thematic areas – Child Supportive Environments and Relationships, Child Safety Online, and Child Focused Response to Abuse. The themes are chosen based on the areas where children are particularly vulnerable, the needs for its work are greatest, and where the organization has the greatest experience and knowledge and thus can make the most difference.

To help achieve its mission and thematic areas, Childhood USA's Advisory Council is an external group of experts who review all applications and meet with Childhood USA's staff to discuss and make recommendations to the Childhood USA Board Program Committee. The members of Childhood USA's Advisory Council are survivors, experts, researchers, and practitioners in many fields regarding children's rights, healing work, LGBTQ+ and human rights, violence and sexual abuse of children, and preventive work with children and families at risk; they also possess a thorough knowledge of the United States and evaluation and monitoring of programs.

In 2022, Childhood USA released the US Out of the Shadows Index, a <u>first-of-its-kind report</u> developed by The Economist Impact. This report is designed to help uncover how states are tackling Child Sexual Exploitation and Abuse (CSEA) both in person and online. The study builds on the <u>Global Out of the Shadows Index</u> that was first released in 2019 and updated in September 2022. The US ranked 6th in the global study in 2019, and devastatingly dropped to 13th in 2022. New research findings on 28 states were released in April 2024 and data on all 50 states will be released in 2025.

## LEADERSHIP



### Mary L. Pulido, Ph.D., Executive Director

Mary L. Pulido, Ph.D. joined The World Childhood Foundation USA as the Executive Director in October 2023. Prior to that time, she served as the Executive Director of The New York Society for the Prevention of Cruelty to Children, the first child protection agency in the world. She has held senior management positions at the Child Protection Center of Montefiore Medical Center (a Child Advocacy Center), the Children's Village, and at Covenant House/Under 21. She holds the rank of adjunct Assistant Professor at the Silberman School of Social Work at Hunter College.

Dr. Pulido's protocol for crisis debriefing following child fatality and critical incidents is utilized throughout the New York City Child Protective Services system. Dr. Pulido is a member of the Medical Reserve Corps of the NYC Department of Health and Mental Hygiene. She served on the National Board of the American Professional Society on the Abuse of

Children (APSAC) and is a member of the Board of the NYS Chapter of APSAC.

In 2006, Mayor Michael Bloomberg appointed Dr. Pulido to the New York City Child Fatality Review Team (CFRT) where she served until 2015. She recently served as a principal investigator on a project to design a child sexual abuse prevention curriculum for elite, Olympic gymnasts, coaches and parents following the child sexual abuse scandal involving Larry Nassar.

Dr. Pulido holds a Ph.D. in Social Welfare from the City University of New York, and Master's Degrees in Social Work from Hunter College School of Social Work and in Teaching from Sacred Heart University. In 2019, she received the Trailblazer Award from the Silberman School of Social Work at CUNY for her contributions to the greater good of the people in NYC. In 2022, she was named one of the "Responsible 100" citizens by City and State New York, for her contributions for improving the lives of children in NYC. In May 2023, she was the Commencement Speaker for the School of Social Work at Sacred Heart University.

She has published in the areas of detection and prevention of child abuse and neglect, providing supervised visitation services, crisis debriefing, child sexual abuse prevention and preventing secondary traumatic stress. She has been featured on WNBC, The New York Daily News, NY1, WPIX-TV, ABC News, cbsnews.com, Inside Edition and is a dedicated blogger on issues of child protection for Huffington Post and Medium.

# REPORTING AND IMPORTANT RELATIONSHIPS

The Director will report to the Executive Director. S/he will work closely and collaboratively with the Board of Directors, staff, volunteer committees, and consultants to lead Childhood USA's fundraising efforts. The candidate will partner with Childhood USA's Director of Programs to understand and create persuasive cases for support for Childhood USA's programs and funding priorities. S/he will staff the External Affairs Committee of the Board of Directors.

In support of Childhood's global mission, the Director will collaborate with Childhood offices across the world to stay up to date on international news and discuss opportunities to collaborate or implement international programs in the United States.

The successful candidate will partner with the Executive Director to staff and support members of the Swedish royal family. The Director will operate in alignment with protocols of the Swedish Royal Court.

- ➤ Implement best practices in development, including a moves management system, cultivation and stewardship strategies, and calendars and systems to track philanthropic activities and events;
- > Identify and carry a portfolio of individual, corporate, and foundation prospects in an environment where the prospective donor constituency is not immediately obvious;

- ➤ Build a robust corporate partnerships and sponsorships program, forging long-term relationships with corporate prospects;
- Create and execute plans to meet annual revenue targets and analyze progress against such targets, identifying strategies to address any potential shortfalls;
- ➤ Lead prospect identification and research to strategically diversify and grow Childhood USA's donor base both locally and nationally;

- ➤ Develop fundraising materials, including the annual report, acknowledgement letters, direct appeals, and select solicitation materials;
- > Partner with Childhood USA's Events Consultant to identify and cultivate event attendees for solicitation; and
- Operate in alignment with protocols of the Swedish Royal Court.

- ➤ Proven ability to provide the strategic direction, leadership, and operational management of fundraising initiatives, resulting in marked improvement and growth;
- Self-starter, independent, and flexible thinker with the ability to pivot quickly between tasks and multi-task to meet deadlines;
- ➤ Demonstrated record of designing and executing strategies for identification, cultivation, solicitation, and stewardship;
